Attendance and School Refusal Twilight

Event Summary	This twilight session will focus on links between school refusal/avoidance and mental health and/or safeguarding concerns.
Event description	<p>This twilight session will explore the links between school avoidance and mental health and not just considering it school refusal.</p> <p>It will also offer strategies to support reintegrating pupils back into school, maintaining this and appropriate referrals. We will also look at strategies to track data effectively and working effectively with external agencies.</p> <p>Finally, we will look at how children absent from education and children missing from education are potential indicators of safeguarding concerns.</p>

Mental Health and Wellbeing: Dealing with Exam Stress

Event Summary	This session will explore a whole-school plan to support students dealing with stress particularly during exam periods. It will also look at strategies to support students individually.
Event description	<p>As the numbers of students requiring exams access due to mental health and decreasing wellbeing increases it has also been reported that school is one of the main causes of stress in students. Developing student resilience and managing stress are key skills that need to be taught in schools and colleges when supporting young people, particularly as they approach key times in their school/college life.</p> <p>This course is suitable for whole-school CPD, which will explore:</p> <ul style="list-style-type: none"> • What is meant by stress - good and bad stress • How stress can present itself • How students can develop good habits and avoid bad habits both in and out of school • Practical ideas to support students when they are feeling stressed • How to develop a whole-school wellbeing module around exam stress • Avoiding pitfalls during the academic year. <p>Following on from this course you will receive a bank of ideas and strategies, which can be used with your students who suffer from exam stress and during lessons when teaching about managing stress.</p>

Safeguarding: Domestic Abuse Awareness

Event Summary	In this webinar we will explore how domestic abuse impacts the lives of children and young people and how to identify the signs.
Event description	Domestic abuse was a factor in 40% of child related deaths and serious harm incidents during 2020 (Multi agency and safeguarding panel briefing, September 2022). This in-depth look at domestic violence, domestic abuse and coercive behaviour will support your establishment's on-going safeguarding CPD programme (KCSIE 2023) in recognising and responding to this type of safeguarding concern. In this 90-minute webinar we will look at how to identify the signs, the role of Operation Encompass, the Domestic Abuse Act (2021), how the RSE curriculum can support your students and how to support pupils living with this type of abuse. We will spend time looking at the impact on families and children who are victims of domestic violence. We will also look out how to support staff members who are living with domestic violence.

Safer Recruitment Training

Event Summary	<p>The Safer Recruitment course covers the key requirements of the Statutory Guidance Keeping Children Safe in Education focusing particularly on:</p> <ul style="list-style-type: none"> • Identifying abuse and recognising offender behaviour • Safer recruitment practices • Creating a safe environment and culture • Dealing with allegations against adults working in educational establishment <p>Since 2010, it has been mandatory in maintained schools and advisory in academies for recruitment panels to have at least one member who has completed appropriate Safer Recruitment Training.</p> <p>This course includes a graded Assessment on understanding of the issues covered.</p>
Event description	<p>All educational establishments are under a duty to provide a safe environment for children and young people. Part of this responsibility includes deterring and rejecting unsuitable people from employment, ensuring that all staff and volunteers are aware of the signs of abuse and understand what action to take and maintaining an attitude of 'it could happen here' where safeguarding is concerned. To support this, since 2010, it has been mandatory in maintained schools and advisory in academies for recruitment panels to have at least one member who has completed appropriate Safer Recruitment Training.</p>
